POU44202: Ethnic Politics and Identity

This module aims to introduce students to past and current research on ethnic politics and identity. After an introductory meeting in the first week, the rest of the module is roughly divided into two parts. Because most of the literature on identity politics focuses on *ethnic identity*, weeks two through six will address the relationship between ethnicity and nation building, conflict, economic performance, and electoral competition. After reading week, we will shift our focus to the study of other identities. Topics in this half of the term will include class, gender, religion, LGBT politics, and European identity. Any one of these topics could be a module in itself, so obviously we will not have enough time to extensively review the enormous literature on class politics, gender and politics, etc. Instead, the second half of the term is designed to introduce students to these areas of study (and in particular, well-received recent scholarship) and identify potential opportunities to make contributions.

Meetings will occur in a face-to-face setting. In addition to our weekly meetings, I have uploaded the below materials to Blackboard. You may find them helpful throughout the term:

ASSESSMENT

Students will be assessed through two essays, a mid-term essay and an end-of-term essay. The mid-term essay counts for 40% of the overall mark while the end-of-term essay counts for 60%. More details for both are provided below:

Mid-term essay (40% of final mark): this essay is due at 11:59pm on Friday, March 18, 2022. It should not exceed 1,500 words in length, including footnotes but not the list of references. I will deduct five points for every 100 words the essay is above the word

limit. I have no preference for any particular citation style, but please make sure you use citation procedures consistently throughout. You should double-space the essay and provide the word count at the beginning. Additionally, all late submissions, unless excused ahead of time by me or justified with a medical note or tutor's note, will be penalized five points per day. Under no circumstances will work be accepted after it has been marked and returned to other students or after the end of the term. The essay should be submitted via Turnitin. You can do so in the "Essay Submission" folder on Blackboard.

For this essay, please respond one of these four questions/prompts. Each corresponds to material from the first half of the term:

- 1. Are salient ethnic identities compatible with a civic, national identity? Why or why not?
- 2. Some studies that examine the relationship between ethnicity and civil conflict/war conclude that diversity makes civil conflict/war more likely, while other studies do not. How can these disparate sets of findings be reconciled?
- 3. Politics are often heavily "ethnicised" in diverse societies, but not always. What factors best explain why ethnicity is highly politically salient in some diverse societies but not in others?
- 4. Some highly diverse societies are very effective at providing public goods while others are not. What best explains this?

End-of-term essay (60% of final mark): this essay is due at 11:59pm on Friday, April 22, 2022. It should not exceed 2,000 words in length, including footnotes but not the list of references. Otherwise, all other instructions from the mid-term essay (regarding penalties, citation style, formatting, etc.) is the same for the end-of-term essay. This essay should be submitted via Turnitin. You can do so in the "Essay Submission" folder on Blackboard.

For this essay, you have two options with respect to the question/prompt. If you would like, you can respond to one of the questions/prompts listed above (obviously, it needs to be one of the three prompts you did not respond to for your mid-term essay). Alternatively, you can submit your own essay question. If you chose the latter option, you will need to submit your proposed question via Turnitin by 11:59pm on Friday, April 8, but can certainly do so earlier. I will regularly check the "Essay Question" folder to see who has submitted and will return feedback promptly. When I review the essay question I may modify it. This is to ensure that we are both satisfied with the essay question. Obviously, your proposed question needs to be connected to the topics covered in this module. Also, please make your question broadly theoretical, i.e., it should not be restricted to a specific place and time. You are certainly welcome to include empirical examples/case studies in your essay, but the argument/conclusions should be generalizable rather than limited to a particular place. Your proposed essay question will not be formally marked/assessed. Instead, I am having students submit the essay question beforehand to make sure that it is appropriate.
